#### Re: **Voluntary Financial Contribution (VFC)**

At Camp Hill State Infants and Primary School (CHSI&PS) we aim to provide a quality and highly engaging education for all children. The Queensland Department of Education (DoE) pays the cost of providing core instruction, administration and facilities for students. The principal may request the parent of a student to consider making a voluntary financial contribution to enhance both the educational service and resources available for student learning, recreation and comfort.

Our Parents and Citizens Association (P&C) endorse our Voluntary Financial Contribution (VFC) annually. The purpose of the VFC is to provide parents with the opportunity to support our school in providing additional enrichment programs and facilities on campus. The program in 2026 will consolidate the 2025 focus, which was on Information Communication Technology and reading resources.

In 2026, the VFC will be a significant funding source for **upgrading our school Information Communication Technology (ICT)**, ensuring all students have access to up-to-date laptops and software essential for their education.

Based on funds received, the school will action in the following order:

1. Purchase of new laptops *to support student device ratio*
2. Purchase of additional laptops to support the implementation of the Australian Curriculum, in particular the introduction of the Australian Curriculum Version 9 Mathematics curriculum
3. Purchase apps for learning differentiation across all curriculum areas, including online Reading resources for families.


